Rubber Lining Business Launch in Thailand
- Facilities and Business Succession from Ajinomoto Group -

We had established Showa Rubber (Thailand) Co. Ltd. (SRT) in 2013 for the purpose of exploring the possibility of rubber business development in Thailand. We would like to inform you that, on March 5, 2015, we concluded a contract to purchase facilities and other related assets from AET manufacturing co., ltd., which is the Thai subsidiary of the Ajinomoto Group, and to succeed their customer base. Herewith, we start rubber lining business in Thailand from April 1, 2015.

# 1. The transaction and its background

We had announced "Acceleration Plan 2012" in 2012 as well as the medium-term management plan for rubber business owned by our subsidiary.

In this plan, one of our objectives is to aim to be "No. 1 rubber lining company in Asia." In accordance with this objective, we decided to carry out the business succession.

AET manufacturing co., ltd. (AET) is the subsidiary of Ajinomoto Co., (Thailand) Ltd. that is the Thai affiliated company of Ajinomoto Co., Inc. (Ajinomoto). They had operated rubber lining business for 22 years in Samutprakarn Province, Thailand as the last business location performing Ajinomoto's lining technique.

Ajinomoto Group requires advanced rubber lining work for their core products in manufacturing process, etc. Therefore, they had developed rubber lining technology and operated the business for themselves. However, with their business perspective of selection and concentration, Ajinomoto Group withdrew the rubber lining business in 1978 in Japan and we succeeded their technologies including materials. Currently, our subsidiary Showa Rubber Co., Ltd. provides rubber lining work for Ajinomoto Group.

Ajinomoto has announced that they shut down AET business in Thailand according to their

selection and concentration perspective. Rubber lining business is valued as the core business for our subsidiary rubber business and we agreed the business succession from AET accordingly.

Herewith, SRT launches rubber lining business in Thailand.

## 2. Business development of our rubber lining business

Metal (iron apparatus) is easily eroded with use of acid or alkaline liquid. Rubber lining has a role to protect important facilities in such conditions. In order to protect apparatus including tanks and pipes, which are used with acid or alkaline liquid in various plants and factories, corrosion-resistant rubber is lined their inside. Therefore, for new construction of various plants and their maintenance work, our rubber lining work is necessary. Typical customers for rubber lining business are chemical plant, water treatment system, power plant, mine, iron manufacture, and engineering company that constructs the plant.

By this business succession, future SRT business will include the following items, covering all the existing AET business as well as lining work with Showa Rubber original material. SRT will provide them throughout inland ASEAN region with focus on Thailand.

- \* Various lining works including rubber and FRP (work in our factory or on-site work)
- \* Maintenance and repair, inspection, and life assessment
- \* Procurement of cored bar (can manufacturing)

Rubber lining is the core business with a history of 60 years by our subsidiary Showa Rubber. SRT will be a significant foothold in Southeast Asian market after our Malaysian factory (Showa Rubber (Malaysia) Sdn Bhd).

Although rubber business of our subsidiary is their family work with a history of 130 years, they suffer from business slump in recent years. However, our group will grow steadily with business strategies such as the expansion of rubber business in Asia in the future. In the rubber business for recent three years, we have hired talented people from Asian countries. For example, a local Malaysian was appointed as the president of our Malaysian subsidiary. With these excellent talents, our organization is almost ready to expand our business in Asian countries and this business launch is the first step.

#### 3. Structure of Thai new subsidiary

Fukuji Ikegami, Plant & Anti-corrosion Business Unit COO in our Japanese subsidiary Showa Rubber Co., Ltd., is appointed to the president of SRT and transferred to Thailand. For the factory manager, Mr. Unit Markmul who had worked as the core talent for AET was appointed.



## 4. Positioning of ASEAN economy and the Thai factory

The succeeded factory is located in the southwest of Thai capital city, Bangkok. Although the area is the industrial zone developed from relatively early stage in Thailand, the conditions there as industrial zone used to be inferior due to bad access from the Thai's largest international port Laem Chabang Port. However, the surrounding logistics has been dramatically improved by the large-scale Bangkok outer loop expressway completed about nine years ago and later road maintenance and improvements.

Thailand is located in node of inland ASEAN or CLMV countries (Cambodia, Laos, Myanmar, and Vietnam), and it is thus in a geographically strategic position. Intersection of Asian Highway Network is formed within Thailand, which connects China through Singapore by the north-south highway and the Pacific Ocean in Vietnam through the Indian Ocean in Myanmar by the eastwest highway.

Under these conditions, land route to the west from Thai capital Bangkok has been constructing to Dawei port in Myanmar, which will be the exit to the economic area of Indian Ocean. The area of our new factory has easier access to various land routes to all areas in Southeast Asia, and its convenience for goods shipping throughout Thailand, Southeast Asian cities, and Indian Ocean economic area has been improving.
